

SAFE VS COMPLIANT WORKER ACCOMMODATION

- Fire exits and electrical safety

Compliant is about ticking the government's boxes. Safe is about doing the right thing—and protecting your investment while you're at it.



The Real Risks of Just Being Compliant

For landholders, contractors, and regional business owners, accommodation is an asset. And like any asset, it can turn into a liability if it's not up to scratch.

Here's how cutting corners on safety (while still being technically compliant) can backfire:

Hot box effect in summer	Compliant vents in place, but not enough to cool the room	Better insulation, shade, passive airflow, smart layouts
Stress or unrest among workers	Rooms meet legal size, but no privacy or breakout space	Dividers, lighting control, community areas, quiet zones
Injury risks	Meets access laws, but stairs are slippery when wet	Anti-slip treads, covered access, proper drainage
High maintenance costs	Materials are allowed by code, but wear fast	More durable fittings, fewer moving parts, smarter design

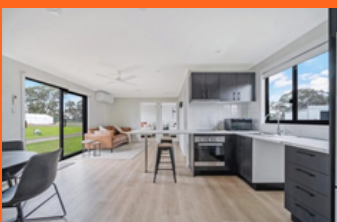
